SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general

: Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. Cardiac arrest: perform resuscitation. Victim conscious with laboured breathing: half-seated. Victim in shock: on his back with legs slightly raised. Vomiting: prevent asphyxia/aspiration pneumonia. Prevent cooling by covering the victim (no warming up). Keep watching the victim. Give psychological aid. Keep the victim calm, avoid physical strain. Remove clothing while washing. Do not remove clothing if it sticks to the skin. Cover wounds with sterile bandage. Consult a doctor/medical service. If burned surface > 10%: take victim to hospital. Remove affected clothing and wash all exposed skin area with mild soap and water, followed by warm water rinse. Thaw frosted parts with lukewarm water. Do not rub affected area. Get immediate medical advice/attention.


